- The school should go through the provision of Affiliation and Examination Bye Laws and keep a copy there 5 of for reference purpose and also advised to visit CBSE websites i.e. http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates. The School is expected to see all circulars on these CBSE websites regularly.
